I reached Raisina Bengali School, Mandir Marg at 2:45 PM to take-up the proceedings. Only one (1) candidate, Mr. Sujit Maity is present to join the proceedings.

Proceedings are taken-up in the presence of Mr. Sujit Maity. Others persons present during proceeding are the Principal of Mandir Marg school, Mr. D. Chakravarty, Assistants to the Returning Officer, Mr. Rakesh Kumar and Mr. Chinmay Sarkar.

All three boxes are empty and the same is video-graphed in the presence of Mr. Sujit Maity. Padlock on each box has been put and locked with the respective key, each lock has set of three keys. A piece of cloth has been wrapped around the padlocks, taking sufficient care that cloth is non-removable except by force. On the knot of the cloth, a brass seal (of the school) has been affixed with the help of Sealing Wax (Lakh) and, the padlocks and the boxes for preserving Voting Paper Envelops have been sealed to my satisfaction of being tamper-proof. I have also put my signature on the padlocks.
